

MINUTES OF VICTIM SUPPORT EUROPE GENERAL MEETING Saturday 17 May 2014 (9:30-11:00 am) Sheraton Hotel, Warsaw

1. Opening and welcome

The President of Victim Support Europe, David McKenna, opens the General Meeting by expressing his heartfelt thanks to Subvenia Victima for the excellent conference.

4. Annual Report 2013

President's report - David McKenna

Key publications in 2013 were the Handbook for Implementation of Legislation and Best Practice for Victims of Crime in Europe and our Manifesto 2014-2019. The

European Commission work plan for 2014 uses the same language as our Manifesto. Many MEPs have also expressed their support for our Manifesto. These are very successful results.

Our Strategy 2012-2015 is now running out and over the last 6 months of 2014, we will develop a new strategy for the future.

In 2013 we organised a very successful event in the European Parliament at which EC Vice-President Viviane Reding held a keynote speech.

<u> Treasurer's report - Helgard van Hüllen</u>

Having properly accounted and audited financial figures for the year 2013 was for me as treasurer again most important. Reliable audited accounts shape the ground for confidence into VSE for our members as well as for external parties such as the European Commission.

Compared with the challenging times we went through with our finances in the past 2013 has been managed in a more relaxed way. Due to an EC operating grant liquidity was not an issue at any times. Nevertheless there still remains the problem of sufficient own financial means without EU subsidy. We need such income to overcome times without grants and/or to finance VSE contributions requested by grants. Here again I would like to thank for the remarkable financial inputs of some members during 2013. The sound financial situation was the basis for all the work that could be done especially with regard to the implementation of the Directive.

I would like to express my sincere thanks to all who have contributed to this solid financial management of VSE in 2013. The post as treasurer was most challenging and I learned a lot. I am now resigning from this position and I will be happy to hand it over to Jo Keaney who has been very supportive during the finalization of the accounts 2013.

The European Commission plans to publish a call for a 3-year framework partnership agreement in September. This will be a big step to secure funding to Victim Support Europe.

The GM unanimously approves the nomination of Sabrina Bellucci to the position of Executive Board Member for her second mandate as a member of the Executive Board.

7. Members' reports

Andrea Heri, Swiss Liaison Centre Committee for the Victims of Crime Act / SVK-OHG

In Switzerland there is a national law on victims' rights and support but the enforcement of the law is the responsibility of the regions ("Cantons"). Each canton has set up a system and has paid staff supporting victims (no volunteers). SVH-OHG is the umbrella institution whose role is to ensure the efficient application of the legal framework regarding victims of crime. It is one of 3 social support institutions which belong to SODK (Swiss Conference of Cantonal Ministers of Social Affairs).

Massimo Tettamanti, I-Care Italy / Associazione Italiana di Supporto Vittimologico

I-CARE is an independent organisation providing support to women and children victims of crime in the north of Italy. It is funded mostly by private foundations. It

started with one secret shelter in Lombardia. Now it consists of 7 secret shelters for maximum 71 victims. I-CARE has a freeline accessible 24H/24-7day/7. The services provided are information, psychological support, legal support, protection. The services are free of charge, confidential and victim-centered.

Olga Kostina, Soprotivlenie, Russia

Over the past years Soprotivlenie has advocated for a package of amendments to the Law aimed at offering better protection for crime victims in Russia. After significant efforts, Soprotivlenie has managed to have these legal changes adopted by the Parliament. Now Soprotivlenie is working on ensuring that the Law is implemented in practice.

Soprotivlenie expresses its deepest gratitude to Victim Support Europe for their help through various inputs.
