## 4. Report of the President- David McKenna

Since the President has already given several speeches during the conference and has mentioned the main issues regarding VSE he will not give an additional report during this AGM.

## 5. Report of the Treasurer – Helgard van Hüllen

The accounts show total income for the year 2010 of EUR €490,959. Victim Support Europe received a pre-financing payment of €130,271 for the 2010 Operating Grant (JUST/2009/JPEN/726/OG) and a pre-financing payment of €299,637 for the 2011/2012 Action Grant (JLS/2009/JPEN/AG/612).

These amounts, prepaid by member organisations of Victim Support Europe are restricted incoming resources and are to be reimbursed to the member organisations.

Victim Support Europe has now 26 members in 21 countries reflecting the growing recognition. The income out of membership fees was  $\in$  13,675. For the year 2010 an operating grant was conceded by the European Commission. The accounts granted in 2010 have to be reimbursed to member organisations. They relate to costs for developing communication supports, the publication of the Newsletters, costs for the secretariat and for the Executive Board as well as the Annual Conference and the AGM. This allowed to develop VSE further.

The year 2010 was the last year for VSE as a company limited by guarantee registered in England and a registered charity. VSE now is an AISBL under Belgian law, situated in Brussels. This will lead to further changes in bookkeeping and auditing.

## 6. Report of the Executive Officer - Frank Hengeveld

The last year has, as indicated by more speakers, been a turbulent one. The report will be short since most of the items to be mentioned have already been raised by other speakers during the last couple of days. Frank thanks David and the Board for all the support given during the last year and also thanks all members of VSE for their contribution.

### 7. Appointment of Board Members

Both new nominations are approved by the AGM. David welcomes both Sabrina and Javed to the Board of Victim Support Europe.

### 11. Resolution 5. New Directive on victims of crime

"This AGM welcomes the new Directive as proposed by the European Commission and will commit itself to the content of it".

There is a short discussion whether or not witnesses should be mentioned in the Directive. The AGM agrees to have the text changed into:

"This AGM warmly welcomes the new Directive as proposed by the EC. We call on the EU to include witnesses in the Directive and to set out its strategy and proposals for funding".

### **12. Future Annual Conferences**

Indicative bids 2012 and 2013 to be decided. APAV is considering to let the conference take place in Lisbon in 2012, Scotland offers to have the 2013 conference in Edinburgh.

### **13. Other resolutions**

No other resolutions have been submitted.

### 14. Any other competent business

Bob Leitch thanks David for the excellent way in which he has acted as President of VSE so far. He believes that the Directive is a major milestone and gives great hope for victims.

Bastian Finke would like to make a proposal for next year's conference as subject of a workshop being hate crime. It would consider violence against refugees, ethical violence, religious violence and violence against GLTB. David thinks this suggestion is very helpful and the Board will consider it to be a key theme of next years conference.
