CAMPAIGN TIMELINE

STEP 1

20 February: Victim Support Europe (VSE) will commemorate the European Day for Victims of Crime on **20 February 2023** with an in-person <u>event 'Achieving Safe Justice for Victims of Crime'</u> at <u>The Press Club Brussels Europe.</u> The event, which will take place from 14:00 to 16:00 (CET), will simultaneously be broadcast live on the **Brussels Press Club TV**.

STEP 2

21 February: Victim Support Europe (VSE) will announce the launch of a new policy paper 'Achieving Safe Justice for Victims of Crime'.

STEP 3

22 February: simultaneous online action conducted by all campaign partners

Victim Support Europe (VSE) will publicise the Joint Statement signed by the leading European NGOs and national civil society organisations (to be shared by the campaign partners on the 22 February)

STEP 4

ACTION WEEK: 23 February - 1 March

Victim Support Europe will be sharing various campaign materials during the action week: victims' testimonies, post-20 February event multimedia materials and the recommendations from its freshly published policy paper 'Achieving Safe Justice for Victims of Crime'.

<u>TEXT QUOTE PHILIPPE ON VISUAL:</u> "My sister was killed by Daesh at the Brussels terrorist attacks in 2016. When you become victim of a terrorist attack, your life, your values, and assurances get completely shaken up. Providing an efficient support is very complex. Justice and truth are key pillars for many victims to rebuild themselves. Yet the justice system's approach is often incomprehensible for the victims as the priorities differ. Due to this, the risk that victims harmed by crime feel unheard, misunderstood and revictimised is real.

Encouragingly, it seems an increasing number of people are willing to step up and meet the challenges. The system does not lack examples of innovation and success, but these need to become the norm. This is why we must all be involved".

Nina Fuchs spoke of how she had been raped while under the influence of a date rape drug, how awful her experience – reporting the crime to the police and seeking justice – was. So terrible, as she told the audience in no uncertain terms, that her experience of the criminal justice system was worse than the rape itself. This is a truly sad indictment of our justice systems, of our responses to victimisation".

TEXT QUOTE ALEKSANDRA ON VISUAL: "No matter the outcome of a criminal proceedings, we can certainly make an effort to reach out to the victims and offer them psychological and other support to help them recover and rebuild their lives. A fundamental shift to achieve this, is the way we measure success in our justice systems. Now, the focus is only on finding people guilty or innocent, and being efficient. We have to include the objective of safe justice – where minimising or preventing harm to victims in the criminal proceedings is as equally important as fair trial rights, and where we measure how successful we are at doing that."

Freja was a victim of rape in Denmark. After that evening, she felt powerless and didn't know who to turn to, to deal with her physical injuries and the fear she was constantly feeling.
