## Background

The EU-funded LITI-GATE project – Strategic Litigation as a Gateway to address the rights of Persons with Disabilities in the European Union –is coordinated by Victim Support Europe (VSE) and implemented over a period of 2 years until 31 October 2025. It brings together 6 partner organisations from 5 countries with the aim to promote enforcement of European law with strategic litigation activities to address breaches of the fundamental rights of persons with intellectual and/or psychosocial disabilities.

The main rationale for the project stems from the evident limited use of strategic litigation for the protection and advancement of the rights of persons with disabilities at both national and European level. The objective of the project is indeed to mainstream the rights of persons with disabilities through existing European legislation, including the EU Charter, the European Convention on Human Rights (ECHR) and other directives in areas including victim's rights, the rights of adult suspect or accused in criminal proceedings, cross border administration of evidence in civil and criminal proceedings, conditions of detention of migrants, suspects or accused of crime with disabilities and cross border movement of people with disabilities. The possibilities to litigate disability rights through the above-mentioned legislation are broad and varied, so the project works on the assumption that such opportunities are generally not seized by legal professionals because they are not known, not seen as relevant or seen as complicated to pursue.

## Concept of the webinar

Across the European Union, persons with intellectual and psychosocial disabilities continue to face significant barriers in accessing justice, despite the guarantees set out in the Victims' Rights Directive and the EU Charter of Fundamental Rights. These barriers are not only procedural and structural but also deeply rooted in stigma, lack of awareness, and insufficient accommodations in legal proceedings. As the Directive undergoes a major recast, there is the urgency to seize the new opportunities that the revised framework more effectively addresses when it comes to the needs of vulnerable groups, including persons with disabilities.

This webinar brings together legal experts, policy professionals, victim support organisations and individuals with lived experience to explore how strategic litigation—grounded in a human rights-based approach—can serve as a catalyst for systemic change. From understanding the evolving legal landscape and crafting compelling arguments to highlighting personal narratives of resilience and exclusion, this session offers rich food for thought for anyone seeking to **use the law as a tool for justice and inclusion**.
