← In 2023, we called on the European Commission, Council, and Parliament to make the 116 006 helpline mandatory in all EU Member States and to provide the necessary EU funding to make it work properly everywhere.

📞 In 2024, the European Council agreed on a proposal to update the Victims' Rights Directive, confirming the need for every Member State to establish an EU-wide, harmonised helpline accessible through the 116 006 number.

Victims of crime deserve more than a number, they deserve equal, high-quality support. That's why this year, we're calling on the EU and Member States to turn commitment into action by ensuring: 📌

- ◆ 116 006 Helplines exist in every Member State
- ◆ 116 006 Helplines meet minimum standards as developed by VSE's Centre of Excellence

Standards 1 & 2

☎ Support isn't support if you can't reach it.

Accessible: No sign-ups, no fees, no barriers. The 116 006 helpline must be accessible to all, no matter the victim.

Available: Real support answers when you call. The helpline should be open for calls at least 40 hours a week, respond within 30 minutes, and stay on as long as necessary.

Because access isn't optional. It's essential. Every victim deserves to be heard.

Post 7

Standards 3 & 4

☎ Real support puts the victim first, and it keeps them safe.

Victim-centred support must always begin with the safety and well being of the victim. That means listening without judgement, offering emotional support, and providing clear, complete information so victims can make informed decisions in their own time.

Privacy is a right. Victims must be able to speak freely, knowing their data is protected, never recorded or shared without their informed consent.

Post 8

Standards 5, 6, & 7

Behind every call is a system built on professionalism and accountability 🛠️

Providers must be not for profit legal entities with victim support at the heart of their mission. Services must be delivered by trained professionals or volunteers equipped to support victims.

Training matters, that's why helpline staff should undergo at least 40 hours of core training, with refresher sessions every year, ensuring they have the skills and knowledge to truly help.

Support can't improve without reflection. Providers must evaluate services at least once a year, and victims should be given the chance to share feedback on their experience.

Standards 8 & 9

 Victims deserve to be heard, before, during and after the call.

Every victim has the right to speak up if something goes wrong. All helplines must provide a clear, accessible way to file complaints, respond within 30 days, and make real changes when needed.

Victims can't reach out if they don't know how. Helplines must actively promote their services through campaigns and outreach, ensuring victims know help exists and how to get it.
